2.3. Other hazards

Asphyxiant in high concentrations. Contact with liquid may cause cold burns/frostbite. In high concentrations CO_2 causes rapid circulatory insufficiency even at normal levels of oxygen concentration. Symptoms are headache, nausea and vomiting, which may lead to unconsciousness and death. Not classified as PBT or vPvB.

SECTION 4: First aid measures

4.1. Description of first aid measures

- Inhalation : Remove victim to uncontaminated area wearing self contained breathing apparatus. Keep

victim warm and rested. Call a doctor. Perform cardiopulmonary resuscitation if breathing

stopped.

- Skin contact : In case of frostbite spray with water for at least 15 minutes. Apply a sterile dressing. Obtain

medical assistance.

- Eye contact : Immediately flush eyes thoroughly with water for at least 15 minutes.

- Ingestion : Ingestion is not considered a potential route of exposure.

4.2. Most important symptoms and effects, both acute and delayed

In high concentrations may cause asphyxiation. Symptoms may include loss of mobility/consciousness. Victim may not be aware of asphyxiation. Low concentrations of CO_2 cause increased respiration and headache.

SECTION 5: Firefighting measures

5.1. Extinguishing media

Suitable extinguishing media : Water spray or fog.

SECTION 7: Handling and storage

7.1. Precautions for safe handling

Safe handling of the gas receptacle

Safe use of the product

The product must be handled in accordance with good industrial hygiene and safety procedures. Do not eat, drink or smoke while working with the product. Wash hands after use. Wear personal protective equipment (See section 8).

Only experienced and properly instructed persons should handle gases under pressure. Consider pressure relief device(s) in gas installations.

Ensure the complete gas system was (or is regularily) checked for leaks before use.

Use only properly specified equipment which is suitable for this product, its supply pressure and temperature. Contact your gas supplier if in doubt.

Avoid suck back of water, acid and alkalis.

Do not breathe gas.

Avoid release of product into work area.

Containers, which contain or have contained flammable or explosive substances, must not be inerted with liquid carbon dioxide. Potential production of solid CO₂ particles must be ruled out. In order to rule out potential electrostatic discharge production, the system must be adequately grounded.

Be aware of the risk of formation of static electricity with the use of CO₂ extinguishers. Do not use them in places where a flammable atmosphere may be present.

: Refer to supplier's container handling instructions.

Protect containers from physical damage; do not drag, roll, slide or drop.

When moving cylinders, even for short distances, use a cart (trolley, hand truck, etc.) designed to transport cylinders.

Leave valve protection caps in place until the container has been secured against either a wall or bench or placed in a container stand and is ready for use.

Open valve slowly to avoid pressure shock. If user experiences any difficulty operating valve discontinue use and contact supplier.

Never attempt to repair or modify container valves or safety relief devices.

Damaged valves should be reported immediately to the supplier.

Keep container valve outlets clean and free from contaminants particularly oil and water. Replace valve outlet caps or plugs and container caps where supplied as soon as container is disconnected from equipment.

Close container valve after each use and when empty, even if still connected to equipment.

Never attempt to transfer gases from one cylinder/container to another.

Never use direct flame or electrical heating devices to raise the pressure of a container. Do not allow backfeed into the container. Suck back of water into the container must be prevented.

Do not remove or deface labels provided by the supplier for the identification of the content of the container.

7.2. Conditions for safe storage, including any incompatibilities

Observe all regulations and local requirements regarding storage of containers.

Containers should not be stored in conditions likely to encourage corrosion.

Container valve guards or caps should be in place.

Containers should be stored in the vertical position and properly secured to prevent them from falling over.

Stored containers should be periodically checked for general condition and leakage.

Keep container below 50°C in a well ventilated place.

Store containers in location free from fire risk and away from sources of heat and ignition. Keep away from combustible materials.

oxygen levels (20-21%) are maintained. 5% CO_2 has been found to act synergistically to increase the toxicity of certain other gases (CO, NO_2). CO_2 has been shown to enhance the production of carboxy- or met-hemoglobin by these gases possibly due to carbon dioxide's

stimulatory effects on the respiratory and circulatory systems.
